## 2012-2013 Bowl Game Congtest Rules



The following are the rules for WPBK-FM's 2012-2013 Bowl Game Contest:

- 1. Employees of WPBK-FM (hereinafter referred to as "Station") and their immediate families are not eligible to participate. "Immediate Family" shall include spouses, parents, children, siblings, grandparents, grandchildren and co-habitating "significant other". Residents of the same household are also considered "Immediate Family", whether or not related by blood or marriage.
- 2. Employees and their immediate families of any other FCC-licensed broadcast stations are not eligible to participate.
- 3. Owners, managers and employees of participating sponsors of this promotion and their immediate families are not eligible to participate.
- 4. No purchase is necessary in order to participate.
- 5. All prizes are awarded to winners on an "as is" basis. Station is not responsible for the condition of the prize itself, nor is the Station liable for any damage or injury caused by any prize awarded by the station.
- 6. Winners agree to allow Station to make use of their name, photograph, likeness and/or audio recording of their voice for advertising and publicity purposes.
- Taxes, if any, are the sole responsibility of the winner. In accordance with IRS regulations, any winner receiving a prize with a value in excess of \$600 will be furnished a copy of IRS Form 1099 (Miscellaneous Income). A copy of this form will also be furnished to the IRS.

- 8. In the event an announced prize becomes unavailable or the supply becomes exhausted, Station reserves the right to substitute a prize of equal or greater value and the winner agrees to accept such prize without limitation.
- 9. Station is not responsible for circumstances beyond its control (telephone malfunctions, postal delivery delays, etc.), that may affect the outcome of a contest.
- 10. An affidavit of eligibility and/or a release from liability may be required in certain instances. Failure to sign such an affidavit, if requested, may result in forfeiture of the prize(s).
- 11.Station reserves the right to suspend this Promotion at any time, if in its judgment, the contest participants have conducted themselves in an unfair manner or attempted in any way to influence the outcome of the contest.
- 12.In the event of a tie, Station reserves the right to conduct a tie-breaking contest, with rules and procedures to be determined by the management of the Station.
- 13. The Station reserves the right to change contest rules and procedures at any time, providing such changes are announced on-the-air prior to their implementation.
- 14.All matters not specifically addressed in these rules shall be determined at the sole discretion of the management of Station.
- 15.In the event of any dispute involving a contest, the decision of Station management is final.

- d. Florida vs Louisville (Sugar Bowl January 2, 2013)
- e. Kansas State vs Oregon (Fiesta Bowl January 3, 2013)
- f. Notre Dame vs Alabama (National Championship January 7, 2013

- 18. The entry deadline is Midnight, December 25, 2012.
- 19. The scoring for the contest will be as follows:
  - a. 1 point for each winner correctly picked
  - b. Tie-breaker will be the total points scored in Championship Game (Notre Dave vs Alabama)
  - c. If there is still a tie after applying the tie-breaker, the winner will be determined by a random drawing from the contestants still remaining after the tie-breaker.
- 20. The prizes for this contest shall consist of a \$100 cash award to the winner. However, if the winner beats any one of the station "experts", then the prize will be doubled to \$200; if the winner beats two of our "experts", the price will be increased to \$300 ; and, if the winner beats all three of our "experts", the prize will be increased to \$400.
